Stand Up and Be Counted River Grove!

The 2020 Census is upon us. Responding to the census is not only your civic duty but it affects the amount of funding that River Grove receives, how we plan for the future, and our representation in government. Specifically, data from the 2020 Census is used to: ensure public services and funding for schools, hospitals, and fire departments; plan new homes and businesses and improve neighborhoods. It also determines how many seats our state is allocated in the House of Representatives.

5 big reasons to fill out your Census:

- 1) **Help your River Grove Thrive!** Census numbers can help our community workout public improvement strategies.
- 2) **Get help in times of need.** Many 911 emergency systems are based on maps developed for the last census. Census information helps health providers predict the spread of disease through communities with children or elderly people.
- 3) **Make your government work for you!** It is a good way to tell our state and national leaders who we are and what we need. The numbers are used to help determine the distribution of hundreds of billions of dollars in federal and state funds. Funding that can be used for hospitals, highways, stadiums and school lunch programs.
- 4) **Reduce risk for American business.** Because census numbers help industry reduce financial risk and locate potential markets, businesses are able to produce the products you want.
- 5) **Help yourself and your Family.** Individual records are held confidential for 72 years. You can request a certificate from past censuses that can be used as proof to establish your age, residence or relationship, information that could help you qualify for a pension, establish citizenship or obtain an inheritance.

Additionally, the Census Bureau will never ask for: social security numbers, bank or credit card account numbers, money or donations, or anything on behalf of a political party. **Please, please, please fill out your Census!**

2020 Roadway Improvements Project

The Village of River Grove is excited to begin construction on the 2020 Roadway Improvements Project, which **includes Budd Street and Hessing Street north of Grand Avenue.**

The project construction cost, \$362,000, is being funded with \$150,000 in funds through a grant from Cook County's Community Development Block Grant and the balance of the roadway improvement costs are being covered by Motor Fuel Tax funds.

Construction will begin the week of July 13th and parking will be affected. There will be several instances when parking will not be allowed on Budd Street and Hessing Street north of Grand Avenue during the day, including the off street parking stalls. The contractor will be posting NO PARKING signs as needed. Weather permitting, construction will be completed in approximately six weeks.

Parking will be available on adjacent streets during construction. Parking restrictions on adjacent streets regarding street sweeping will be temporarily lifted during construction. The village will enhance its traffic patrol of the area to ensure that traffic is compliant with the speed and stop sign regulations during construction.

Work will include surface removal and resurfacing, replacing defective curb & gutter and sidewalk, concrete parking stall installation, and restoration. Garbage collection will not be affected and will continue as normal.
