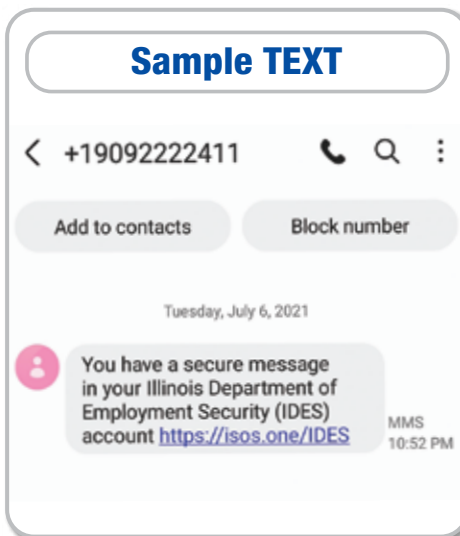
A Few Maintenance and Enforcement Reminders:

- **Is your pet registered?** For the safety of our residents and their pets the village requires that owners purchase an annual pet license (cats & dogs) that expires every June 30th. The license requires proof of rabies vaccination and the fee is \$5. There is no late fee, so if you haven't already, please stop by the village to purchase.
- **Per village code** – pets must be leashed when in a public area.
- **Please keep garbage receptacle lids closed.** Keeping lids closed keeps litter in and animals out!
- **Help to keep the village looking great** by keeping your garage apron free from weeds and debris.

From the River Grove Police - IDES Phishing Scam

A new phishing scam is going around involving text messages allegedly sent from the **Illinois Department of Employment Security (IDES)**. IDES has confirmed that they will never send out a text message asking for personal information, such as a social security number, driver's license number, and date of birth. If you receive an unsolicited text message from the IDES (see the example picture), ignore and block it. If you have provided personal information through a text message link, report the potential fraud to IDES immediately call **(800) 814-0513**.
