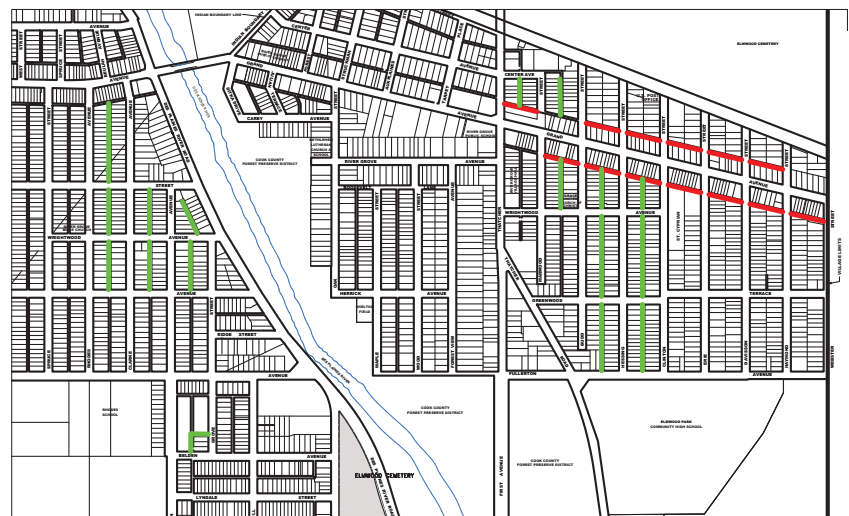
Information and Reminders

- Spring is here! Please be a good neighbor and pick up any trash around the outside of your house, including the ad paper that is delivered Tuesday (they tend to accumulate).
- Items too large for your trash can will need a yellow sticker placed on it. Stickers can be purchased at the Village Hall for \$2. We recommend not applying to the items until Monday morning when the garbage pick-up is scheduled.
- Yard waste pick-up began April 4th. Please bundle sticks and have out by 7 a.m. Mondays.
- A reminder from the **Water Department**: Our water rates will be increasing due to the City of Chicago raising their rates to all surrounding communities. This increase will be passed on to our residents. As a Village, we must maintain clean and safe drinking water.



2022 RG Alley Improvement Program

- All residents and businesses who are directly affected have been notified in more detail.
- Commercial alley construction will start on or about 4/11/22 through approximately 7/22/22.
- Grand Ave. asphalt alleys will be replaced with concrete alleys.
- Residential alley construction will start on or about 4/11/22 through approximately 6/24/22.
- Residential alleys will be replaced with green concrete alleys.
- Each alley will take approximately 28 days during which there will be no access to garages, or parking lots from the alley.
- Start dates will vary. One week prior to the start of construction a sign will be placed at either end of the alley indicating that work will begin in seven (7) days.
- Street maintenance parking restrictions will be lifted while alley is being worked on.
- The remainder of alleys included in this project will be completed next year.

Public Safety Information

Through the use of public safety software provided by Frontline Public Safety Solutions (**Frontline PaSS**), officials from the Village of River Grove are excited to announce the introduction of four new reporting products. As of Monday May 2, 2022, new online reporting modules will provide residents with the ability to request overnight parking permission, request a vacation watch on their residence, register a pet or pets with the village, and register a bicycle with the village online. Where applicable, all reporting products will follow guidelines of established municipal ordinances, and all requests or registrations immediately filter to the proper department. For example, the overnight parking module allows users to create entries of authorized vehicles and their specific locations to request parking permission, and this information becomes available in real-time to patrol officers – saving both time and resources as it relates to requesting parking permission. Additionally, residents will have the ability to register their pet(s) on-line. After entering as much descriptive information as possible, pet owners should also upload a photo of their pet(s). Once the information is entered and confirmed by the resident, it becomes immediately available to authorized users within the village. By using the registration program, lost pets have the best chance of being reunited with their people. Residential vacation watch requests and resident bike registration work in the same fashion.

The village is happy to provide these user-friendly, easily accessible, and secure methods of communicating needs, but as previously mentioned these services continue to follow established rules set forth in municipal ordinances.

*** Please note – Pet Registration:** Residents registering pets through the online system will have 14 days to apply for, and purchase, a village authorized pet registration tag. The cost of the pet registration tag is \$5.00 per pet, and the request for registration tags may be made in person or through the mail. Residents who purchase registration tags in person can opt to have their pet information entered in the database by a village representative.
