Quiet Zone Designation Becomes a Reality

On October 4, 2023 the Village of River Grove finally received approval to establish a **Quiet Zone**. Mayor Guerin and the Village Engineers have been meeting and working with federal, state and local agencies for several years to accomplish this.

While the railroads have been notified of the new **24-Hour Quiet Zone** across the Villages of Franklin Park and River Grove, and it has been noticeably quieter in town, it should be known that the train engineer is still in control of the horns and will utilize the horn in certain safety related and emergency situations. Mayor David B. Guerin stated, *"I am thrilled to report that the application review period has passed without objection, and a Quiet Zone designation will go into effect over the next several weeks. This designation will significantly decrease train horns that are required ahead of each pedestrian crossing."* Additionally, the Mayor added, *"I appreciate the community's patience during this long process, and I want to thank the Village of Franklin Park and Mayor Pedersen for partnering with us on this effort."*

With this Quiet Zone designation train engineers will no longer be legally required to sound the train horns. However, if the train engineer perceives a threat on or near the tracks, the train horn will be sounded. If the engineer sees a car, pedestrian, or an animal on the tracks or feels that there is a danger to the train ahead, they can still blow the horn. Also, an engineer can sound their horn when passing another train, if a train is stopped on the tracks, or if a passenger train is stopped at the station picking up passengers.

Property Tax Bills Coming

Residents owning property in River Grove pay property taxes to the Cook County Treasurer twice a year. The second installment tax bill will be mailed to residents in early November and will be due on December 1, 2023.

Resident's bills for this tax year take into account the Cook County triennial (every three year) reassessment of individual property values. This process takes into account changes in the market values of properties that are required to be assessed by state statute. For 2022 taxes, River Grove, as well as all the towns in Leyden Township, are experiencing market values increasing 25% to 30% over the same property's value three years ago. This increase in value will also usually result in an increase in the amount of taxes a resident will pay.

For your awareness, the Village's share of your property tax bill, depending on the combination of taxing districts the property is located in, is between 26% and 29% of the total bill. The other portions of the bill go to the Village's fine schools, library and other local governmental bodies.

River Grove Senior Snow Removal Program

East Leyden High School students will be assisting our River Grove Seniors with snow removal. A shovel may need to be provided; the resident will verify with the student. **The rate will be \$10.00 per house and includes the following:**

- A path from your front door to your sidewalk/street/stairs
- A path from your back door to your garage door
- Additional charges will apply for the following and will be discussed and handled with the student that is assisting you:
 1. Salting (resident must provide salt)
 2. Shoveling driveways, carport, parking space(s)
