The fee for registering and the initial inspection plus one (1) re-inspection is \$150.00 plus \$25.00 for each rental unit. If additional re-inspections are needed, a \$100.00 re-inspection fee will be charged for each re-inspection.

## IMPORTANT NOTICE

### DEAR RENTAL DWELLING OWNER/MANAGER:

Under Village of River Grove ordinance 7-21-2, rental property owners are subject to registration and inspections of all rental unit buildings every two (2) years. All single-family rental homes and rental condos every year. (ORD. 2024-01)

Please complete and return to the Village of River Grove the enclosed registration form and the required fee (\$150.00 plus \$25.00 for each rental unit) as described in the ordinance.

When returning your registration form please be sure to include the following:

1. Registration form completely filled out and signed.
2. Required fee (see example: 6 unit = \$150.00 plus \$25.00 for each unit – total fee \$300.00)

Upon receipt of the required documents and payment of the required fee the Village will schedule the property inspection.

Under Section (k), any person violating the terms and conditions of this code shall be subject to a penalty not exceeding seven hundred fifty dollars (\$750.00) with each and every day that the violation of the code is allowed to remain in effect being deemed a complete and separate offense. In addition, the appropriate authorities of the Village may take such other action as they deem proper to enforce the terms and condition of this code, including, without limitation, an action to compel compliance with its terms, that any person violating the terms of the code shall be subject, in addition to the foregoing penalties, to the payment of court costs and reasonable attorney fees. (ORD. 1997-06, 8-7-1997, EFF. 10-1-1997)
